ORDER REINSTATING PATS CERTIFICATE NO. 2307

BY THE COMMISSION:

On June 14, 1989, this Commission granted a certificate to provide pay telephone services, PATS Certificate No. 2307, to Trace Associates (Trace). On January 7, 1992, in accordance with Rule 25-4.0161, Florida Administrative Code, Trace mailed to this Commission its regulatory assessment fee form for the period covering July 1 through December 31, 1991. However, Trace's form was inadvertently misplaced.

By order PSC-92-0888-FOF-TC, issued August 27, 1992, we ordered Trace to show cause why it should not be fined for failing to file its form. Trace responded to the show cause order by providing a copy of its form as filed. Nevertheless, through a second administrative oversight, Trace was placed on the list of entities that had failed to respond to the show cause order and its certificate was cancelled.

Since it appears that Trace timely complied with the requirements of Rule 25-4.0161, Florida Administrative Code and Order No. PSC-92-0888-FOF-TC, and since it also appears that it was only through this Commission's inadvertence that PATS Certificate No. 2307 was cancelled, we find it appropriate to rescind that portion of Order No. PSC-92-0888-FOF-TC that pertains to Trace and reinstate PATS Certificate No. 2307.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the portion of Order No. PSC-92-0888-FOF-TC that pertains to Trace Associates is rescinded. It is further

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water or sewer utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Civil Procedure. The notice of appeal must be in the form specified in Rule 9.900 (a), Florida Rules of Appellate Procedure.
