SPECIFIED CONFIDENTIAL CLASSIFICATION

COMES NOW, BellSouth Telecommunications, Inc., d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and files its Notice of Intent to Request Specified Confidential Classification.

1. The Staff of the Florida Public Service Commission ("Staff") has issued several Audit Requests in its "1992 Update" audit in the above-captioned docket, requesting, among other things, that Southern Bell make available for viewing computer diskettes containing financial transactions affecting BellSouth Telecommunication's regulated and non-regulated accounts for the State of Florida for the years 1991¹ and 1992.

2. Some of the information contained in the responsive computer diskettes to be reviewed by the Staff is clearly proprietary. For example, some of the documents and data contain financial information on non-regulated affiliates and non-regulated services, employee-specific information unrelated to compensation, duties, qualifications, or responsibilities, and other proprietary confidential business information. This

information is entitled to proprietary and confidential treatment pursuant to § 364.183, Florida Statutes and Rule 25-22.006, Florida Administrative Code.

3. Consequently, because these documents contain proprietary confidential business information, Southern Bell is filing this Notice of Intent to Request Specified Confidential Classification, pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, in order to allow the Staff to take possession of the documents without delay. The original of this notice and copies of the staff requests have been filed with the Division of Records and Reporting, and a copy has been served on the Division requesting the information.
