3. In this docket, the Commission will examine the ramifications of the FCC's recent order on expanded interconnection and collocation on the Florida telecommunications market. FIXCA members are interexchange carriers and are one of the groups entitled to expanded interconnection on the interstate level pursuant to the FCC order. They will be substantially affected by decisions the Commission makes on the expanded interconnection and collocation issues as they affect intrastate traffic. In addition, FIXCA members may wish to purchase services from alternative access vendors who will be subject to the Commission's decision in this docket.

4. Thus any decision which the Commission makes on these issues on the intrastate level will affect FIXCA's substantial interests.

WHEREFORE, FIXCA requests the Commission to enter an order authorizing it to intervene and participate as a full party in the above proceeding.
