COMMISSION STAFF'S PREHEARING STATEMENT

A. All Known Witnesses

Staff may call Ms. Francis J. Lingo as a witness. If called, Ms. Lingo will testify concerning the escrow requirement established in Order No. 24084, issued February 8, 1993.

Staff may introduce the exhibits attached to Ms. Lingo's prefiled testimony into the record of this proceeding.
