COMES NOW BellSouth Telecommunications, Inc. d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and pursuant to Rule 25.22.006, Florida Administrative Code, files its Notice of Intent to Request Specified Confidential Classification.

1. The Staff of the Florida Public Service Commission ("Staff") has issued several Audit Requests in connection with the NARUC/FCC Regional Audit of BellSouth. Staff has requested, among other things, that Southern Bell furnish the following information:

2. Audit Request No. 1-015.3, dated May 21, 1993 - "Provide a list of all non affiliates that BSTI has sold any technology to since January 1992 to present. Include the type of technology sold, the total cost of the transaction and what BSTI accounts were utilized in the transaction."

Audit Request No. 2-081, dated May 20, 1993 - "Re Data Serv: Provide Data Serv's investment in the Atlanta Repair facility in 1992."

3. Some of the information requested is clearly proprietary. For example, the information requested contains


nonregulated affiliate company financial information and contractual information relating to transactions between BellSouth Telecommunications, Inc. and non-affiliated companies. Such information is specifically considered to be proprietary confidential business information pursuant to § 364.183(3), (3)(d) and (3)(e), Florida Statutes.

4. Consequently, because this information contains proprietary information, Southern Bell is filing this Notice of Intent to Request Specified Confidential Classification, pursuant to Rule 25-22.006(3)(a)(b)(5), Florida Administrative Code, in order to allow the Staff to review this information without delay. Both the original of this notice and the individual requests have been filed with the Division of Records and Reporting, and a copy has been served on the Division requesting the information. The written Staff Request is attached hereto.
