

ALLTEL FLORIDA'S MOTION FOR PARTIAL
MODIFICATION OF ORDER NO. 25340

ALLTEL Florida, Inc. ("ALLTEL" or the "Company"), pursuant to Rule 25-22.037, Florida Administrative Code, files this Motion for Partial Modification of Order No. 25340, and says:

1. ALLTEL's ability to fully comply with Order No. 25340 is dependent on Southern Bell's ability to comply with Order No. 25340.

2. On June 18, 1993, Southern Bell filed a Motion for Partial Modification of Order No. 25340 on grounds that its request for waiver of the MFJ has been denied.

3. ALLTEL joins Southern Bell in its request for a Partial Modification of Order No. 25340 for the reasons set forth in Southern Bell's Motion for Partial Modification of Order No. 25340, dated June 18, 1993.


WHEREFORE, ALLTEL requests that the FPSC enter an order partially modifying Order No. 25340 to reflect the fact that Southern Bell, and, therefore, ALLTEL, cannot provide the \$0.25 calling plan on routes which cross a LATA boundary.
