COMES NOW BellSouth Telecommunications, Inc. d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and pursuant to Rule 25.22.006, Florida Administrative Code, files its Notice of Intent to Request Confidential Classification.

1. The Staff of the Florida Public Service Commission ("Staff") has issued several Audit Requests in connection with the NARUC/FCC Regional Audit of BellSouth. Staff has requested, among other things, that Southern Bell furnish the following information:

date) is not included here because there was no information in this Field.

Audit Request No. 2-104, dated June 17, 1993 - "Has C&L Minneapolis completed their independent analysis of inventory reserves? If so, provide a copy. If not, provide expected completion date."

3. Some of the information being provided is clearly proprietary. For example, the information being provided contains financial and other business information relating to non-regulated affiliate companies, employee specific information unrelated to compensation, duties, qualifications or responsibilities, vendor specific pricing and other contractual information.
