The Staff of the Florida Public Service Commission, by and through its undersigned attorney, hereby requests that Turkey Creek Utilities (utility) produce copies of the following documents, pursuant to Rule 1.350, Florida Rules of Civil Procedure, at the office of Catherine Bedell, Esquire, Senior Attorney, Division of Legal Services, Florida Public Service Commission, Suite 232, 101 East Gaines Street, Tallahassee, Florida 32399-0863, within thirty (30) days of service of this request.

1. The utility provided a quit-claim deed instead of a warranty deed. Produce a warranty deed or a quit-claim deed with title insurance in the correct name of the utility.
2. Provide a copy of all of the water and wastewater portions of the Development of Regional Impact (DRI) and documentation of its approval by the Department of Community Affairs..
3. Provide documentation of the DER rated capacity of the water and wastewater treatment plants.




