Stated a little more plainly, if the Commission is convinced that the 1" meters are required by City Ordinance then one set of submitted tariff sheets is appropriate. If the Commission decides that the Ordinance does not require 1" meters, but that the 1" meters were installed as a result of a good faith misunderstanding and dispute, then the second set of revised tariff sheets are appropriate.
