TO THE PREHEARING OFFICER:

Central Telephone Company of Florida ("Central Telephone" or the "Company") respectfully requests leave to file its Prehearing Statement after the due date. In support of its request, the Company states as follows:

1. The Order on Prehearing Procedure (Order No. PSC-93-0811-PCO-TP) issued by the Prehearing Officer established July 8, 1993, as the date for the parties to file Rebuttal Testimony and their Prehearing Statements. With the completion of the merger of Centel and Sprint, the principal focus of the Company and United Telephone Company of Florida has been the development of a united regulatory approach, which included the preparation of the Direct and Rebuttal Testimony of F. Ben Poag and United Telephone Company of Florida's Prehearing Statement. The Company's Prehearing Statement adopts United Telephone Company of Florida's statement of basic position and its position on the issues identified in the Order on Prehearing Procedure.


2. The Company intends to continue to participate in this proceeding, and its participation will be of significant benefit to
