## ORDER GRANTING CONFIDENTIAL TREATMENT TO SPECIFIC MATERIAL CONTAINED IN DOCUMENT NO. 6103-93

On January 6, 1993, by Order No. PSC-93-0029-PCO-TL we required that BellSouth Telecommunications, Inc. d/b/a Southern Bell Telephone and Telegraph Company (Southern Bell or the Company) prepare traffic studies on the routes under consideration for Extended Area Service in this Docket. By Order No. PSC-93-0764-PCO-TL, issued on May 20, 1993, we granted the Company an extension of time for filing the studies until June 7, 1993. On that day the Company filed a Request for Confidential Treatment of certain information contained in the required studies. The studies in question have been assigned Document No. 6103-93 by the Commission. In support of its Request the Company asserts:

- 1. that the traffic data relates to toll usage over the various routes at issue;
- 2. that the information is proprietary information maintained by Southern Bell on a confidential basis to plan its network deployment based on traffic demand over the respective toll routes;
- 3. that disclosure of the information would harm the Company by allowing its competitors in the intraLATA toll market to target the most lucrative routes.

Upon review, I find that the material is proprietary business information pursuant to Section 364.183, Florida Statutes, and Rule 25-22.006, Florida Administrative Code. As such, it shall be kept confidential and shall be exempt from Section 119.07(1), Florida Statutes.

I note that Southern Bell has filed a Motion for a Modification of Order No. PSC-93-0029-PCO-TL. That Motion will be addressed in a separate Order.

Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.038(2), Florida Administrative Code, if issued by a Prehearing Officer; (2) reconsideration within 15 days pursuant to Rule 25-22.060, Florida Administrative Code, if issued by the Commission; or (3) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Director, Division of Records and Reporting, in the form prescribed by Rule 25-22.060, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
