1. On February 22, 1993, JEA submitted a Plan to Eliminate Duplicative Electric Facilities within the corporate boundaries of Jacksonville. The plan stated that JEA would present an offer to purchase OREMC's customers and equipment.
2. While purchase proposals have been tendered which JEA believes to be fair and reasonable, OREMC and JEA have yet to reach an agreement.
3. JEA wishes to continue negotiations for a reasonable period before exercising its eminent domain option.
