3. MCI is an interexchange carrier (IXC) certified by the Florida Public Service Commission. MCI currently provides interexchange service to customers within the State of Florida.
4. This docket relates to issues regarding the terms and conditions on which MCI will be provided access to the local

exchange networks. As such, MCI's substantial interests may be affected by the Commission's action in this docket.

5. Attached hereto is a copy of MCI's Prehearing Statement on the issues identified in Order No. PSC-93-0811-PCO-TP.
