**MCI TELECOMMUNICATIONS CORPORATION'S  
PREHEARING STATEMENT**

MCI Telecommunications Corporation (MCI) hereby submits its Prehearing Statement in the above-captioned docket.

A. Known Witnesses. MCI does not intend to sponsor any witnesses.

B. Known Exhibits. MCI does not intend to offer any exhibits, other than possible cross-examination exhibits.

C. Basic Position. MCI believes that expanded interconnection in the intrastate special access market is in the public interest. The Commission should implement such expanded interconnection in a way that does not give a special advantage to any one carrier.

D. - G. Issues. Except for Issues 1, 10 and 15, MCI takes "No position at this time" on each of the issues identified in the Order on Prehearing Procedure.

**ISSUE 1:** Is expanded interconnection for special access and/or private line in the public interest?

**MCI:** Yes, provided such expanded interconnection is implemented in a way that does not give a special advantage to any one carrier.

**ISSUE 10:** Should the same terms and conditions of expanded

interconnection apply to AT&T as apply to other interconnectors?

**MCI: Yes.**

**ISSUE 15: If the Commission permits expanded interconnection, what pricing flexibility should the LECs be granted for special access and private line service?**

**MCI: No additional pricing flexibility is required.**

**H. Stipulations. MCI is not aware of any issues that have been stipulated by the parties.**

**I. Pending Motions. MCI has no pending motions that require action by the Prehearing Officer.**

**J. Requirements of Order. MCI believes this prehearing statement is fully responsive to the requirements of the Order on Prehearing Procedure.**
