NOTICE OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION

COMES NOW BellSouth Telecommunications, Inc. ("BST") d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and files its Notice of Intent to Request Confidential Classification.

1. The Staff of the Florida Public Service Commission ("Staff") has issued several Audit Requests in the referenced docket in connection with the NARUC/FCC Regional Audit of BellSouth. The Staff has requested, among other things, that Southern Bell make available for viewing the following information:

2. Audit Request No. 2-097, dated June 10, 1993 - "For BSE: Provide at BSE HDQ Accounting Offices, a meeting starting 6/22/93, to discuss and have available for review the following:

8 - Provide by Subsidiary the amounts BSE billed each Sub for the management fee in 1992 and the amount BSE billed each Sub for project billing for 1992."

3. Some of the information being provided is clearly proprietary. For example, the information being provided contains contractual market rate information including information on non-regulated and non-affiliated companies and other financial information relating to non-regulated affiliates.
