MOTION TO EXTEND TIME TO FILE TESTIMONY

Jim Cherry, individually and on behalf of the Turkey Creek Master Owners Association, Inc. hereby requests that should he be granted intervenor status, the Commission should permit him to file his testimony on or before September 20, 1993, the same date the Staff is permitted to file its testimony. In support of this motion the proposed intervenor states:

1. Order No. PSC-93-1151-PCO-WS, establishing procedure in this docket, provides that intervenors file their testimony on or before September 7, 1993; with the Staff filing on or before September 20, 1993; and the Utility's rebuttal due on or before October 4, 1993.

2. Affording the proposed intervenor the additional two weeks to file his testimony will assist him in providing meaningful testimony in this docket without prejudicing the rights of any other party to this docket.

3. Permitting all of the nonutility testimony to be filed on or before September 20, 1993 will still permit the utility to retain the 2 weeks it currently has to file its rebuttal testimony.

4. Since the proposed intervenor's testimony is anticipated to be in support of Staff's positions already taken in this docket the utility should not be prejudiced buy this request.




