OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION

COMES NOW, BellSouth Telecommunications, Inc. d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and pursuant to Rule 25.22.006, Florida Administrative Code, files its Notice of Intent to Request Confidential Classification.

1. The Staff of the Florida Public Service Commission ("Staff") has issued several Audit Requests in connection with the NARUC/FCC Regional Audit of BellSouth. Staff has requested, among other things, that Southern Bell furnish the following information:

2. Audit Request No. 3-095, dated August 31, 1993 - "Provide the 1993 allocation factors in the same format as provided in 3-044, 3-045, and 3-046."

3. Some of the information being provided is clearly proprietary. For example, the information being provided contains financial accounting and other business information relating to a non-regulated affiliate. Such information is specifically considered to be proprietary, confidential business information pursuant to § 364.183(3)(e), Florida Statutes.
