Dear Commissioner Clark:

Thank you for your letter dated September 2, 1993 concerning NARUC's Regional Audit of BellSouth Telecommunications, Inc. Let me assure you that BellSouth Enterprises is committed to cooperation with the Florida Commission, within the law and to the extent of its available resources, to provide timely and complete responses to requests that your audit team may make.

In retrospect, it may well have been a mistake to attempt to run the NARUC audit in parallel with the Florida proceeding. As you know, we agreed to this procedure in an attempt to be responsive to NARUC and in order to gain some protection for our competitive information. It is always difficult, if not impossible, to run an audit by a private organization under the auspices of a public agency. And, I am sure that this hybrid procedure has caused you frustration as well as us.

To make sure we are doing everything we can in proceedings such as this, BellSouth Corporation recently established a regulatory department headed by Randy New who is our Assistant Vice President for Legislative and Regulatory Matters. I have asked him to contact you and to discuss fully with you, consistent with your statutory obligations, the issues that you raised in your letter. Moreover, Carlton Baker, Group President - Regulatory and External Affairs of BellSouth Telecommunications, has sent a letter to Dennis Nagel, the current President of NARUC, asking for his assistance in facilitating the audit process. A copy of his letter is attached.
