

1. The Staff of the Florida Public Service Commission ("Staff") has issued several Audit Requests in connection with the NARUC/FCC Regional Audit of BellSouth. Staff has requested, among other things, that Southern Bell furnish the following information:

contains financial and other proprietary business information of


non-regulated affiliates, affiliate and non-affiliate competitive lease information, employee specific information unrelated to compensation, duties qualifications or responsibilities, corporate credit card information, vendor specific pricing information, customer-specific billing and contract information, non-regulated affiliates' product specific information and competitive lease-related information pertaining to non-regulated affiliates' transactions with non-affiliates. Such information is specifically considered to be proprietary, confidential business information pursuant to § 364.183(3) and (3)(d), (e) and (f), Florida Statutes.

4. Consequently, because this information contains proprietary information, Southern Bell is filing this Notice of Intent to Request Confidential Classification, pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, in order to allow the Staff to review this information without delay. Both the original of this notice and the individual requests have been filed with the Division of Records and Reporting, and a copy has been served on the Division requesting the information. The written Staff Requests are attached hereto.
