OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION

COMES NOW, BellSouth Telecommunications, Inc. d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and pursuant to Rule 25.22.006, Florida Administrative Code, files its Notice of Intent to Request Confidential Classification.

1. The Staff of the Florida Public Service Commission ("Staff") has issued several Audit Requests in connection with the NARUC/FCC Regional Audit of BellSouth. Staff has requested, among other things, that Southern Bell furnish the following information:

2. Audit Request No. 1-060.2, dated September 17, 1993 - "Explain BSE direct participation as member of the Heathrow Executive Steering Committee during the fiber based field trials at Lake Mary, Florida.

Provide a copy of the joint venture Agreement between BSE and Heathrow as shown on the attached Heathrow organization chart.

Provide documentation which effected the transfer of BSE interest in the Heathrow joint venture to BellSouth Services. Reference Executive Steering Committee meeting held on 1/11/89, Executive Summary, which stated 'A letter was written from BSE requesting that BellSouth Services assume responsibility for their joint venture position with Paulucci International.' If this transfer did not take place, please explain."

3. Some of the information being provided is clearly proprietary. Such information is specifically considered to be proprietary, confidential business information pursuant to § 364.183(3)(d) and (e), Florida Statutes.

Consequently, because this information contains proprietary information, Southern Bell is filing this Notice of Intent to Request Confidential Classification, pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, in order to allow the Staff to review this information without delay. Both the original of this notice and the individual requests have been filed with the Division of Records and Reporting, and a copy has been served on the Division requesting the information. The written Staff Requests are attached hereto.
