OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION

COMES NOW, BellSouth Telecommunications, Inc. d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and pursuant to Rule 25.22.006, Florida Administrative Code, files its Notice of Intent to Request Confidential Classification.

1. The Staff of the Florida Public Service Commission ("Staff") has issued several Audit Requests in connection with the NARUC/FCC Regional Audit of BellSouth. Staff has requested, among other things, that Southern Bell furnish the following information:

2. Audit Request No. 2-155, dated September 22, 1993 - "Provide the total charged to BST from each affiliate for return on investment as part of their FCC calculation for 1992. Include rate charged. Also include a breakdown of the total billed from these affiliates by BST cost pool and amount.

Provide same information if the affiliate bills other affiliates. Include name of affiliate, rate and amount of ROI.

Include source of amounts obtained from all of the above. For all affiliates billing at FDC, this amount should be on the bill.

Information should be presented in a format similar to the following:

The written Staff Requests are attached hereto.
