REQUEST: Filing Information. Refer to the Company's response to Interrogatory 823, That interrogatory asked the Company "As the Company discovers errors in its filing or determines that additional adjustments are appropriate, identify this information currently and provide documentation to support any changes." The Company merely responded that no corrections or adjustments have been made in the Company's filing. In response to OPC-824, the Company stated "The Company has also discovered that, for its expiring amortization pro forma, an incorrect amortization amount was used." The Company also identified errors in the filing as part of responses to the OPC's thirty-seven set of interrogatories dated August 4, 1993. Please identify each error discovered to date. Each error should be specifically identified, including any calculations necessary to show the revised amount and where the error was made.

RESPONSE: Since updating Witness Reid's testimony and certain Minimum Filing Requirements schedules on October 1, 1993, the Company has determined that the amount of unprotected deferred tax on MFR Schedule C-23f for the test year 1993 and the historical period 1992 is overstated. The Company filed revised MFR Schedules C-23f on November 1, 1993 to show the proper amounts. The Company has also identified revisions to MFR Schedule C-23e for the historical period 1992. See Item 1170. The Company also filed a revised MFR Schedule C-23e on November 1, 1993. Neither of these corrections affects the test year results. The Company has also determined that the model used to budget amortization expense included one additional months' expense for some vintages of general purpose computers and corporate communications equipment. See Item 1161. The impact of that change reduces budgeted "book" depreciation by \$2,272,000 and increases budgeted "book" net operating income by \$1,396,000.
