COMES NOW, BellSouth Telecommunications, Inc. d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and pursuant to Rule 25.22.006, Florida Administrative Code, files its Notice of Intent to Request Confidential Classification.

1. The Staff of the Florida Public Service Commission ("Staff") has issued an Audit Request in connection with the NARUC/FCC Regional Audit of BellSouth. Staff has requested, among other things, that Southern Bell furnish the following information:

2. Audit Request No. 2-097.10F, dated August 24, 1993 - "Please have a representative (Malice Whatley) explain her potential chaining study for 12/31/92 while we are here this week in Atlanta (8/17/93). Provide a copy of potential chaining study. You supplied us with the representative and a copy of the ESPI study for our review. We need a copy of this ESPI study sent to Miami BST office for our further review."

The written Staff Requests are attached hereto.
