BY THE COMMISSION:


On November 11, 1993, this Commission issued Order No. PSC-93-1604-FOF-WS, amending Certificates Nos. 146-W and 103-S, held by Poinciana Utilities, Inc., to include additional territory in Osceola County. The word "feet" was inadvertently omitted from the next to the last line of the territory description shown on Attachment A of that Order. The line should be amended to read "1,776.51 feet to the East Line of the Northeast 1/4 of...." The territory description has been corrected and is set forth on Attachment A of this Order, which by reference is incorporated herein.

SUMMIT HILL SUBDIVISION

In Township 26 South, Range 29 East

Section 7: The Southwest 1/4 of the Northwest 1/4

In Township 26 South, Range 28 East

Section 12: From the Northeast corner of the Southeast 1/4 of the Northeast 1/4; run South 00° 04' 23" East 211.93 feet along the East Line of the Northeast 1/4 of Section 12, Township 26 South, Range 28 East, to the Point of Beginning (P.O.B.); thence run South 89° 43' 03" West 1,729.79 feet; thence North 25° 08' 28" West 77.99 feet; thence run North 00° 08' 59" West 314.61 feet to a point being on the Southeasterly right-of-way of State Road 535 (Ham Brown Road); thence run Southwesterly along the southeasterly right-of-way of State Road 535 and the arc of said curve 558.60 feet said curve having chord bearing of South 44° 05' 05" West and a chord distance of 539.08 feet; thence run North 89° 43' 03" East 342.82 feet; thence South 25° 11' 48" East 78.57 feet; thence South 00° 08' 59" East 1,252.40 feet; thence run North 89° 42' 41" East 1,776.51 feet to the East Line of the Northeast 1/4 of Section 12; thence run North 00° 46' 50" West 1,320.47 feet to the P.O.B.
