COMES NOW BellSouth Telecommunications, Inc. d/b/a/ Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and hereby files its Notice of Withdrawal of Request for Confidential Classification, and states the following:

1. On June, 29, 1993, the Florida Public Service Commission Staff ("Staff"), propounded upon Southern Bell by mail its First Set of Interrogatories, which included Interrogatories No. 1 through 45. When Southern Bell filed its response to these interrogatories, on August 3, 1993, it also filed a Notice of Intent to Seek Confidential Treatment for certain proprietary information that was provided in response to Interrogatory No. 42.

2. On August 24, 1993, Southern Bell timely filed its Request for Confidential Classification as to this information. Subsequent to the filing of this request, Southern Bell determined that it would be appropriate to withdraw the request

for confidentiality of the information that was provided in response to Interrogatory No. 42. Therefore, Southern Bell hereby withdraws its Request for Confidential Classification for the information provided in response to Interrogatory No. 42 and files this Notice of the withdrawal.
