1. This information could be directly or indirectly used to trace the source of the information back to an employee. As such, this information is proprietary, confidential business information pursuant to Section 364.183(3)(e) (competitive service rate information) and Section 119.07(3)(w) (customer's name and address), Florida Statutes and is exempt from the requirement of public disclosure of Section 119.07, Florida Statutes.

3. This information is employee personnel information unrelated to compensation, duties, qualifications and responsibilities. As such, this information is confidential business information pursuant to Section 364.183, Florida Statutes, and is exempt from the requirement of public disclosure of Section 119.07, Florida Statutes.
