OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION

COMES NOW, BellSouth Telecommunications, Inc. d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and pursuant to Rule 25.22.006, Florida Administrative Code, files its Notice of Intent to Request Confidential Classification.

1. The Staff of the Florida Public Service Commission ("Staff") has issued an Audit Request in connection with the NARUC/FCC Regional Audit of BellSouth. Staff has requested, among other things, that Southern Bell furnish the following information:

2. Audit Request No. 3-142, dated November 3, 1993 - "Provide the affiliate expense booked by BAPCO during 1992 and 1993 if different than responses to Data Requests 3-053 and 3-0121. If different, explain why."

3. Some of the information being provided is clearly proprietary. For example, the information being provided contains billings between non-regulated affiliates and cost information of an unregulated affiliate. Such information is

specifically considered to be proprietary, confidential business information pursuant to § 364.183(3)(e), Florida Statutes.

4. Consequently, because this information contains proprietary information, Southern Bell is filing this Notice of Intent to Request Confidential Classification, pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, in order to allow the Staff to review this information without delay. Both the original of this notice and the individual requests have been filed with the Division of Records and Reporting, and a copy has been served on the Division requesting the information. The written Staff Requests are attached hereto.
