SOUTHERN BELL TELEPHONE AND TELEGRAPH COMPANY'S NOTICE  
OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION

COMES NOW, BellSouth Telecommunications, Inc. d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and pursuant to Rule 25.22.006, Florida Administrative Code, files its Notice of Intent to Request Confidential Classification.

1. The Staff of the Florida Public Service Commission ("Staff") has issued several Audit Requests in connection with the Continuing Property Records (CPR) Review Audit of Southern Bell. Staff has requested, among other things, that Southern Bell furnish the following information:

2. Audit Request No. 10 - "Please explain the type of costs booked under the following CPR numbers (See CPR list for each location in Req #11).

CPR No. 040004 (Acct Loc E0605, E0128, E2443)  
CPR No. 040001 (Acct Loc E0609, E0126, E0128 - \$12,561.30)  
CPR No. 268240 (Acct Loc E0126 - \$13,603.20, E0128 - \$12,561.30)

- a) Furnish detailed support documents (work orders, invoices, journal entries, etc.) for each entry
- b) Give justification for capitalizing these costs for each entry."

Audit Request No. 11 - "A physical inventory of CPR's for our Vero Beach locations was conducted on 11/5/93 and 11/8/93 by joint, PSC and SBT staff. The CPR records and locations (copies attached) were selected from records provided by the company to PSC EDP group in Tallahassee.

The inventory found the attached listed discrepancies. Please reconcile the quantities and provide support documentation (journal entries, transfer documents, work orders, etc.) for each discrepancy at each of the four locations."

Audit Request No. 12 - "Please explain the type of costs booked under the following CPR numbers (see CPR list for each location in Request 13).

CPR No. 04004 (Acct Loc. E0032, E9962, E0539, E0027, E0034)  
CPR No. 04001 (Acct Loc. E9962, E0539, E0027).

- a) Furnish detailed support documents (work orders, invoices, journal entries, etc.) for each entry.
- b) Give justification for capitalizing these costs for each entry."

Audit Request No. 15 - "Please furnish all the support documents (work orders, journal entries, invoices, etc.) for the underlined entries on the attached list (plug-in)."

Audit Request No. 17 - "Please provide a hard copy of the CPR record for location E0605 (ISS 43rd CT. Vero Beach) CPR to include both hardwire and plug-ins."

3. Some of the information being provided is clearly proprietary. For example, the information being provided contains unit cost information for equipment purchased by Southern Bell for provision of telecommunication services.

Such information is specifically considered to be proprietary, confidential business information pursuant to § 364.183(3)(d), Florida Statutes.

4. Consequently, because this information contains proprietary information, Southern Bell is filing this Notice of Intent to Request Confidential Classification, pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, in order to allow the Staff to review this information without delay. Both the original of this notice and the individual requests have been filed with the Division of Records and Reporting, and a copy has been served on the Division requesting the information. The written Staff Requests are attached hereto.
