The application filed in the above referenced docket is deficient for the following reason:

1. It did not contain evidence that the utility owns the land upon which the utility treatment facilities are located, or a copy of an agreement which provides for the continued use of the land, such as a 99-year lease as required by Rule 25-30.037(1)(o), Florida Administrative Code. We are aware that the closing of the sale is contingent upon Public Service Commission approval. Therefore, we will not be requiring a copy of the executed deed until after the transfer is approved.


