SOUTHERN BELL TELEPHONE AND TELEGRAPH COMPANY'S NOTICE
OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION

COMES NOW, BellSouth Telecommunications, Inc. d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and pursuant to Rule 25.22.006, Florida Administrative Code, files its Notice of Intent to Request Confidential Classification.

1. The Staff of the Florida Public Service Commission ("Staff") has issued several Audit Requests in connection with the Work Activity Statistical Sampling Process (WASSP) Review Audit of Southern Bell. Staff has requested, among other things, that Southern Bell furnish the following information:

2. Audit Request No. 1 - "Please provide answers to the attached 9 items."

Audit Request No. 7 - "Please answer the attached question regarding service technician time reporting."

Audit Request No. 9 - "(1) Regarding D&T, Page 32, Exhibit D - March 5, 1993 B-2 assures 15 minutes savings per day. Provide study. (2) D&T Florida Riding Exercise - Did they prepare an annual net cost savings? If so, provide. (3) Provide documentation for FCC changes regarding "analysts talking to ST"

and analysts getting source documentation of ST's." (4) Provide any other changes from D&T recommendations by the FCC.

Audit Request No. 10 - "(1) Copy of the sample selection formula and precision formula. (2) October 1993 three month aggregate list in Florida."

3. Some of the information being provided is clearly proprietary. For example, the information being provided contains internally developed and commercially valuable business information, employee specific information unrelated to compensation, duties, qualifications or responsibilities, customer specific information. Such information is specifically considered to be proprietary, confidential business information pursuant to § 364.183(3)(a), (3)(e), and (3)(f), and § 119.07(3)(w), Florida Statutes.

4. Consequently, because this information contains proprietary information, Southern Bell is filing this Notice of Intent to Request Confidential Classification, pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, in order to allow the Staff to review this information without delay. Both the original of this notice and the individual requests have been filed with the Division of Records and Reporting, and a copy has been served on the Division requesting the information. The written Staff Requests are attached hereto.
