If Option 1 is exercised, an interconnect shall be completed within 9 months of the date of the Order. If Option 3 is exercised, the remediated wells shall be cleared bacteriologically and all chemical analysis required for community public water systems shall be received within 6 months of the effective date of the Order.		
III. Current Status: Option 1 has been selected. A special meeting of the Town Council was held on July 27th approving a resolution giving authority to serve outside the Town limits. The Town of Welaka approved the interconnection agreement on August 10, 1993. SSU has filed a permit application with FDER. Permit to construct interconnect approved by FDER December 14th. Citrus Pipeline started construction January 10th and completed construction on January 19th. Awaiting bacteriological results and final clearance from FDER before activating interconnect.
