OBJECTION TO CITIZENS' SECOND SET OF INTERROGATORIES  
TO ST. GEORGE ISLAND UTILITY CO., LTD.

St. George Island Utility Co., Ltd., a Florida limited partnership, ("Utility") objects to the second set of interrogatories filed by the "Citizens," and as grounds for this objection would show the Commission as follows:

1. In its first set of interrogatories filed in this cause on February 11, 1994, the "Citizens" propounded approximately 75 interrogatories, including subparts, to the Utility. By PSC Order No. 94-0320-PCO-WU issued March 21, 1994, the Commission

limited interrogatories by any party, including all subparts, to 50.

2. Despite the fact that the "Citizens'" first set of interrogatories exceeded both the limitation of 30 set forth in the Florida Rules of Civil Procedure, and the limitation of 50 set forth in the above-referenced Commission order, the Utility nevertheless responded to all of the approximately 75 interrogatories previously propounded by the "Citizens."

3. The "Citizens'" second set of interrogatories is far in excess of the 50 limitation set forth in the above-referenced order, and the Utility should not be compelled to answer

interrogatories in violation of such order.


4. The "Citizens'" second set of interrogatories amounts to nothing more than additional, continued harassment of the Utility, which will have no result other than to increase the cost of this rate case.

5. Interrogatories numbered 34, 35 and 36 are not relevant or material to any issue before the Commission in this docket.
