
GTE FLORIDA INCORPORATED'S
WITHDRAWAL OF MOTION FOR EXTENSION

By Order number PSC-94-0285-FOF-TP, issued in this docket on March 10, 1994, the Commission ordered the local exchange companies (LECs) to submit zone-density pricing plans and tariff proposals by March 31, 1994. The Commission instructed the LECs to use their FCC interstate zone-density tariffs and plans as a guide.

On March 31, 1994, GTE Florida Incorporated (GTEFL) filed a Petition for Extension of the filing date for the zone-density pricing plans and tariff proposals. GTEFL hereby withdraws that Petition. The Company has come to an accommodation with the Commission Staff and now plans to file a zone-density plan for special access within about a week.
