CITIZENS' MOTION TO STRIKE REBUTTAL TESTIMONY

The Citizens of the State of Florida, by and through Jack Shreve, Public Counsel move to strike certain rebuttal testimony filed or to be filed by St. George Island Utility Company, Ltd. (SGU) and as grounds therefore say:

1. By motion dated June 16, 1994, SGU moved this Commission for an extension of time for filing rebuttal testimony which, if granted, would have permitted the filing of the testimony on July 11, 1994.
2. Order No. PSC-94-0802-PCO-WU, denied SGU's motion, but extended the time for filing the rebuttal testimony until July 7, 1994.
3. On July 7, 1994, shortly before the deadline established by order of this Commission, SGU filed the rebuttal testimony of witnesses F. Seidman, M. Garrett, B. Withers, W. Colony, and T. Bidby.

4. No other rebuttal testimony was filed by the close of business on July 7, 1994.
