OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION

COMES NOW, BellSouth Telecommunications, Inc. d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and pursuant to Rule 25-22.006, Florida Administrative Code, files its Notice of Intent to Request Confidential Classification.

1. On July 8, 1994, the Staff of the Florida Public Service Commission served its Fifth Set of Interrogatories to Southern Bell. Staff requested, among other things, that Southern Bell furnish the following information:

2. Item No. 60 - "Please refer to Tariff Section E6.8.1 A. For the company's usage rate per access minute, please provide the cost per access minute. Please provide this information for Southern Bell and Independent companies concurring in Southern Bell's tariff."

3. The information requested contains actual incremental unit cost information for discrete rate elements for switched access service provided by Southern Bell and the independent telephone companies. Further, the information concerning the independent telephone companies' cost of access was previously provided to Southern Bell under protection of a proprietary

agreement. Such information is specifically considered to be proprietary, confidential business information pursuant to § 364.183(3), (3)(c) and (3)(e), Florida Statutes.

Consequently, because this information contains proprietary information, Southern Bell filing this Notice of Intent to Request Confidential Classification, pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, in order to allow the Staff to review this information without delay. Both the original of this notice and the individual requests have been filed with the Division of Records and Reporting, and a copy has been served on the Division requesting the information.
