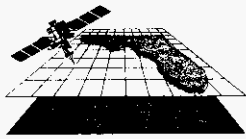

The Florida Cable Television Association, Inc. ("FCTA"), pursuant to Order No. PSC-94-0893-PCO-TL and Rule 25-22.038(3), Florida Administrative Code, respectfully submits its Prehearing Statement in the above-captioned docket.

A. WITNESSES AND EXHIBITS

FCTA does not intend to call any witnesses or present exhibits. However, FCTA reserves the right to call witnesses, if necessary, as may be required by later filed testimony, the completion of discovery, or new issues identified at the prehearing conference.

B. BASIC POSITION

FCTA's primary interest in this proceeding is to support the Commission's determinations of Order Nos. PSC-94-0172-FOF-TL and PSC-94-0669-FOF-TL.

C. ISSUES AND POSITIONS

FCTA offers the following positions on the questions of law, fact and policy currently to be disposed of in this docket:

ISSUE ONE: Under the terms of settlement, is the Florida Public Service Commission required to hold a hearing on the rate design issues to implement the proposed rate reductions?

FCTA's POSITION: Yes.

ISSUE TWO: Under applicable law, does the Commission have the authority to adopt the CWA proposal?

FCTA's POSITION: No. The determination as to how the first round of rate reductions stemming from the Settlement and Implementation Agreement will be implemented is solely the responsibility of the Commission.

ISSUE THREE: Whether the rate reductions described in Order No. PSC-94-0669-FOF-TL are in the public interests of the payor?

FCTA's POSITION: Yes.

D. STIPULATIONS

FCTA is unaware of any matters that have been stipulated at this time.

E. PENDING MOTIONS


FCTA has no motions or other outstanding matters pending at this time.
