COMES NOW, Interexchange Access Coalition ("IAC") and files pursuant to Rule 25-22.006, Florida Administrative Code, a Notice of Intent to Request Confidential Classification ("Notice").

1. On April 20, 1994, Southern Bell Telephone and Telegraph Company ("Southern Bell") served its First Set of Interrogatories on IAC. Southern Bell requested, among other things, that IAC furnish the following information:

2. Item No. 5 - "Please provide for IAC and each of its members, the average revenue per minute of use for its intrastate toll service in Florida."

3. Item No. 10 - "For IAC and each of its members, please provide the average intrastate switched access cost per minute of use for toll services in Florida."

4. IAC provided this information on a confidential basis in its Additional Responses and Objections to Southern Bell Telephone and Telegraph Company's First Set of Interrogatories filed with the Commission on June 7, 1994.



5. Southern Bell has now requested that it be allowed to present this confidential information at the hearing on August 23, 1994.
