MOTION FOR EXTENSION OF DURATION
OF ORDER GRANTING CONFIDENTIAL CLASSIFICATION
Order No. PSC-93-0404-CFO-TL (Docket No. 920260-TL)

COMES NOW, BellSouth Telecommunications, Inc., d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company") and files, pursuant to Rule 25-22.006, Florida Administrative Code, its Motion for Extension of Duration of Order Granting Confidential Classification, and states as grounds in support thereof the following:

1. On January 20, 1993 Southern Bell filed a Request for Confidential Classification for responses to request numbers 129 and 130 in response to Staff's Fourteenth Request for Production of Documents. The Commission assigned two different sets of document numbers which identify this information, 15028-92 - 15029-92 and 813-93.

2. By an Order issued March 16, 1993, the Florida Public Service Commission ("Commission") granted Southern Bell's Request for Confidential Classification of information contained in these documents. (Order No. PSC-93-0404-CFO-TL) Specifically, the Commission approved Southern Bell's request for confidential classification of information relating to Southern Bell's cost to provide services, route specific information regarding Microtel's deployment of facilities and vendor-specific and service specific pricing negotiated by Southern Bell.

3. Under the provision of Rule 25-22.006 (8) (a), an order granting confidential classification is effective for 18 months. Therefore, the confidential classification granted in this Order expires on September 16, 1994. The Commission may, however, extend the period of confidentiality for good cause shown.

4. The information in question remains in the possession of the Staff.

5. The reasons Southern Bell asserted in support of confidential treatment in its original motion continue to pertain. Specifically, there is still a need to protect vendor-specific product and pricing information from disclosure.

6. For the reasons set forth above and in the original Request for Confidential Classification filed on January 20, 1993, Southern Bell hereby requests that this Commission enter an Order extending the period of confidential classification for an additional 18 months, or for any longer period of time that the documents remain within the possession of staff.

WHEREFORE, for the reasons set forth above, Southern Bell respectfully requests the entry of an Order extending the period of confidential classification as described above.
