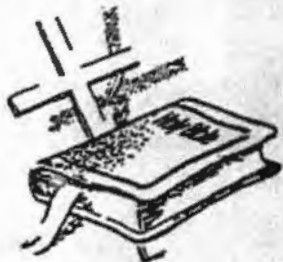


Dear Public Servant:
