MOTION FOR EXTENSION OF DURATION
OF ORDER GRANTING CONFIDENTIAL CLASSIFICATION
Order No. PSC-93-1062-CFO-TL

COMES NOW, BellSouth Telecommunications, Inc., d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company") and files, pursuant to Rule 25-22.006, Florida Administrative Code, its Motion for Extension of Duration of Order Granting Confidential Classification, and states as grounds in support thereof the following:

1. On December 23, 1992, Southern Bell filed a Request for Confidential Classification for information provided to Staff in connection with the audit related to BellSouth Telecommunications, Inc.'s rate case and Cost Allocation Manual Supplement (CAMS). On January 22, 1993, Southern Bell a revised index of confidential information for the rate case audit workpapers. The Commission

assigned Document Nos. 14888-92, 14890-92 - 14898-92 and 692-93 respectively to this material.

2. By an Order issued July 21, 1993, the Florida Public Service Commission ("Commission") granted in part and denied in part Southern Bell's Request for Confidential Classification of the information contained provided for the audits. (Order No. PSC-93-1062-CFO-TL) Specifically, the Commission approved Southern Bell's request for confidential classification for internal audit information, notes taken from internal audits, audit procedures of outside auditors, the company's strategies regarding competitive products or services and account balance information for competitive interests of Southern Bell and non-regulated affiliates of Southern Bell.

3. Under the provision of Rule 25-22.006 (8) (a), an order granting confidential classification is effective for 18 months. Therefore, the confidential classification granted in this Order expires on January 20, 1995. The Commission may, however, extend the period of confidentiality for good cause shown.

4. The information in question remains in the possession of the Staff.

5. The reasons Southern Bell asserted in support of confidential treatment in its original motion continue to pertain. Specifically, there is still a need to protect internal audit information, audit procedures of outside auditors, account balance information for competitive interests and non-regulated affiliates and strategies regarding competitive products or services from


disclosure.

6. For the reasons set forth above and in the two original Request for Confidential Classification filed on December 23, 1992, Southern Bell hereby requests that this Commission enter an Order extending the period of confidential classification for an additional 18 months, or for any longer period of time that the documents remain within the possession of staff.


WHEREFORE, for the reasons set forth above, Southern Bell respectfully requests the entry of an Order extending the period of confidential classification as described above.
