Dear Mr. Childs:

Staff would like to cover the following areas with Mr. Birkett:

1. Proposed Fuel Allocation Methodology;
2. Treatment of Recovered Costs as it relates to Real Time Pricing; and
3. FPL's recovery of the \$2,754,502 million for the cost of implementing certain equipment modifications at some of its generating facilities to operate using a less expensive grade of residual fuel oil.

With regard to item #3, Mr. Birkett should bring FPL's complete analysis and be prepared to discuss the assumptions, calculations, a detailed explanation of the modifications, and the justification for method recovery (through fuel as opposed to base rates). Staff will probably request that FPL provide a copy of the analysis as a deposition exhibit.




