**SOUTHERN BELL TELEPHONE AND TELEGRAPH COMPANY'S
MOTION FOR MODIFICATION OF ORDER NO. PSC-95-0080-PCO-TL**

BellSouth Telecommunications, Inc., d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), hereby moves the Florida Public Service Commission ("Commission") pursuant to Rule 25-22.037, Florida Administrative Code, to modify Order No. PSC-95-0080-PCO-TL, entered in the above-referenced docket, and states as grounds in support thereof the following:

1. On January 17, 1995, this Commission issued Order No. PSC-95-0080-PCO-TL, which directed Southern Bell to prepare and submit within 90 days (i.e., by April 17, 1995) a traffic study of the routes between the Groveland Exchange and the Orlando, Winter Garden, and Windermere Exchanges. All of the above are interLATA routes.

2. On June 7, 1993, Southern Bell filed a Motion for Modification of Order No. PSC-93-0029-PCO-TL in Docket No. 921193-TL (In re: Request by Palm Beach County Board of County Commissioners for Extended Area Service Between all Exchanges in

Palm Beach County) in a situation that is identical to the present one. Specifically, Southern Bell had attempted to conduct a traffic study on the routes at issue in that case on several occasions, but had been unable to obtain valid traffic study results. Upon further investigation, Southern Bell determined that because these routes included interLATA traffic, Southern Bell no longer had access to the information necessary to conduct the traffic study. Southern Bell does not carry this interLATA traffic, and the carrier of this traffic no longer provides this information to Southern Bell. Accordingly, Southern Bell requested that this Commission modify the above-referenced order to release Southern Bell from the obligation to provide the traffic study on these interLATA routes. That motion was granted in an order that was entered on August 10, 1993 (Order No. PSC-93-1168-FOF-TL).

3. The situation that pertained in that docket also pertains here. In other words, the routes in question here are also interLATA routes, and Southern Bell is unable to provide a traffic study of these routes. For this reason, this Commission should treat this matter the same as the identical situation was treated in the earlier docket described above, i.e., this Commission should grant this motion and relieve Southern Bell of

the obligation to perform a traffic study on the above-described interLATA routes.

WHEREFORE, Southern Bell respectfully requests the entry of an order granting its Motion for Modification of Order No. PSC-95-0080-PCO-TL.
