1. The Staff of the Florida Public Service Commission has issued certain a requests for documents dated March 22, 1995, in connection with the Audit of Accounting for CPE. The Staff has requested that Southern Bell furnish the following information:

Please provide the total number of additional phone lines added in Florida as a result of the promotion."


