

WHEREAS, the Board of County Commissioners of Dixie County, Florida believes that such EXTENDED AREA SERVICE would be in the best interest of the health, safety and welfare of the citizens of Dixie County, Florida.

NOW THEREFORE BE IT RESOLVED by the Board of County Commissioners of Dixie County, Florida that the Public Service Commission is hereby requested to initiate the procedure to determine the suitability of EXTENDED AREA SERVICE for the following exchanges in Dixie County, Florida:

498 (CROSS CITY) with 493, 463 and Gainesville

542 (OLD TOWN) with 463, 493 and Gainesville

BE IT FURTHER RESOLVED that a copy of this Resolution be filed with the Public Service Commission in order to initiate that process.
