Florida Power & Light Company ("FPL") hereby Petitions this Commission for approval of FPL's final Environmental Cost Recovery true-up amount of \$882,358 overrecovery for the October 1994 - March 1995 period and an overrecovery of \$419,418 as the adjusted net true-up amount to be carried forward to the October 1995 through March 1996 period. In support of this Petition, FPL states as follows:

1. The final \$882,358 Environmental Cost Recovery overrecovery for the period October 1994 - March 1995, was calculated in accordance with the methodology set forth in Schedule A-2 for the Fuel Cost Recovery Clause, attached to Order 10093 dated June 19, 1981. This calculation and the supporting documentation are contained in the prepared testimony of FPL witness B. T. Birkett, which is being filed together with the Petition and incorporated herein.

2. The adjusted net true-up for the period of an overrecovery of \$419,418 is the difference between the actual true-up of \$882,358 overrecovery and the estimated/actual true-up of \$462,940

overrecovery approved by the Commission at the March 1995 hearing.


WHEREFORE, Florida Power & Light Company respectfully requests the Commission to approve the net \$882,358 environmental cost recovery overrecovery as the final true-up amount for the period ending March 1995, and an overrecovery of \$419,418 as the adjusted net true-up amount to be carried forward to the period beginning October 1995.
