

1. Pursuant to the Case Assignment and Scheduling Record dated February 14, 1995, the due date for submitting of pre-filed testimony by TVWC was May 8, 1995.

2. Specific testimony to provide information in support of the application was prepared by Sanford M. Martin, representing Tamiami Village Utility Inc., present holder of Certificate No. 388-W.

3. The subject testimony was prepared and submitted by Martin but was not received by the Division of Records and Reporting until May 10, 1995, two days after the due date.

4. The testimony was not received by the Division of Records and Reporting until May 8, 1995 because of the illness of a legal assistant and the use of a temporary employee who mailed the testimony to the wrong address,

resulting in a five day delay in delivery; in addition, Mr. Martin was attending a hearing in Ft. Myers and thereby unaware of the incorrect mailing until May 6, 1995 when the error was corrected and additional copies mailed to the Commission.

5. Mr. Martin was responsible for the pre-filing of this testimony and has expressed his apology for the failure to timely file the subject testimony, and he and the Petitioner hopes that the delay has not caused delay or inconvenience to other parties or to Commission staff.
