# APPLICATION OF SOUTHERN STATES UTILITIES, INC. FOR INCREASED WATER AND WASTEWATER RATES, ALLOWANCE FOR FUNDS PRUDENTLY INVESTED AND SERVICE AVAILABILITY CHARGES

SOUTHERN STATES UTILITIES, INC. ("SSU"), hereinafter referred to as the "Applicant", pursuant to Rule 25-30.436, Florida Administrative Code, hereby files its Application for authority to increase water and wastewater rates and charges and states as follows:

1. The name and principal business address of the Applicant is as follows:

2. The persons authorized to receive notices, orders, pleadings and other documents and communications with respect to this Application are as follows:

- 3. Applicant was incorporated on November 22, 1961 under the laws of the State of Florida and is currently authorized to conduct business in the State of Florida. Applicant is a wholly-owned subsidiary of Topeka Group, Inc. ("Topeka"). Topeka Group, Inc.'s address is 30 West Superior Street, Duluth, Minnesota 55802.
- 4. This Application is filed pursuant to Chapter 367, Florida Statutes (1993 and Supp. 1994), and, in particular, Sections 367.081 (Supp. 1994) and 367.082, Florida Statutes (1993).
- 5. Applicant requests that this Application be scheduled for formal hearing and not be processed pursuant to the Proposed Agency Action procedure outlined in Section 367.081(8), Florida Statutes (Supp. 1994).
- 6. An affidavit signed by Forrest L. Ludsen, Vice President Finance and Administration of the Applicant, stating that Applicant will comply with the noticing requirements set forth in Rules 25-22.0407 and 25-22.0408, Florida Administrative Code, for applications for water and wastewater rate increases, allowance for funds prudently invested and service availability charges is attached hereto as Appendix "A".
- 7. Except as may be specifically identified herein, Applicant does not know of any manner in which this Application deviates from the policies, procedures or guidelines prescribed by the Commission in relevant rules or prescribed by the Commission in Applicant's last rate case.
- 8. Four checks in the amounts of \$4,500, \$4,500, \$2,250 and \$2,250 accompany this Application as the filing fees for the requests for increased water and wastewater rates and water

and wastewater service availability charges, respectively.

- 9. Applicant provides water and wastewater service in 139 service areas (96 water and 43 wastewater service areas), in 22 counties pursuant to certificates issued by the Commission. In addition, Applicant currently has pending before the Commission an application requesting approval of the transfer to Applicant of the water and wastewater facilities currently owned by Orange-Osceola Utilities, Inc. in the Buenaventura Lakes service area (Osceola County). This application for increased water and wastewater rates and service availability charges includes all of the 141 service areas.
- 10. The names of the 141 service areas, the county in which each service area is located, the certificates of authority pursuant to which Applicant provides service to each service area and the number of the Commission's last order which previously considered Applicant's rates for each service area are identified in Appendix "B".
- 11. The documents containing the minimum filing requirements ("MFRs") in support of and accompanying this Application are outlined in Appendix "C" and are incorporated herein by reference.
- 12. This Application and supporting documents may be inspected at the locations listed in Appendix "D".
- 13. The necessity for a rate increase arises from the fact that Applicant did not earn a fair and reasonable rate of return for the base year ended December 31, 1994 and, based on the budget for the interim test year ended December 31, 1995 and the projections for the final test year ended December 31, 1996, Applicant will earn no return on equity during 1995 and 1996.
  - 14. For the 96 water service areas filed in this Application (excluding Buenaventura

Lakes), Applicant experienced a rate of return of only 5.32% and a return on common equity of .26% during the base year ended December 31, 1994. For the interim test year ending on December 31, 1995, Applicant projects a rate of return of only 4.29% and a negative return on equity of -1.87% from water operations. For the final test year ending December 31, 1996, Applicant projects a rate of return of only 3.05% and a negative return on equity of -5.52%.

- 15. For the 43 wastewater service areas filed in this Application (excluding Buenaventura Lakes), Applicant experienced a rate of return of only 5.62% and a return on common equity of .98% during the base year ended December 31, 1994. For the interim test year ending December 31, 1995, Applicant projects a rate of return of only 4.21% and a negative return on equity of -2.05% from wastewater operations. For the final test year ending December 31, 1996, Applicant projects a rate of return of only 4.39% and a negative return on equity of -2.26%.
- 16. The primary reason for the continued deterioration of returns through 1995 and 1996 is the addition of more than \$97 million to plant in service for water and wastewater operations since rates last were established. Appendix E provides two schedules which breakdown the additional plant in service by water, wastewater and general plant categories as well as by priority code. The MFRs identify each project added to plant in service, by service area, since rates last were established.
- 17. The Applicant proposes and will establish in this proceeding that a fair and reasonable rate of return on its combined water and wastewater rate base is 10.32%. This proposed rate of return is based in part on the Commission's approval of a return on equity invested in water and wastewater operations of 12.25%. The requested return on equity is based

on the Commission's leverage graph formula, as modified to make the formula consistent with Applicant's particular business and financial risks and to correct certain mistakes in the application of the formula.

- 18. Applicants requested return on equity of 12.25% reflects a reduction from the otherwise required return on equity in anticipation of the Commission's approval of the weather normalization clause ("WNC") proposed by Applicant. The WNC is designed to provide monthly adjustments to the gallonage charge for water service based on deviations from the consumption per bill identified in this proceeding. Applicant anticipates that Commission approval of the WNC will materially reduce the business and financial risk to which Applicant is exposed thereby reducing Applicant's cost of debt and equity, stabilizing revenues and moderating the frequency of rate relief requests associated with weather and other variables beyond Applicant's control.
- 19. Based on the application of the Conservation Rate Structure Study and Elasticity Study performed by the Southwest Florida Water Management District, Applicant has determined that (1) the base facility/gallonage charge proposed in this Application is a conservation rate structure and (2) consumption in the 1996 projected test year should be reduced by 10.9%. Therefore, Applicant has made this adjustment to consumption in the MFRs.
- 20. Based on the foregoing and in order to have an opportunity to earn a fair and reasonable rate of return on the rate base for water and wastewater services, the Commission should allow Applicant to place into effect final rates which will produce additional sales revenues for water operations of \$11,791,242 and for wastewater operations of \$6,346,260. These increases result in consolidated water revenues of \$37,950,163 and consolidated wastewater

revenues of \$27,352,361. The combined increase in revenues from water and wastewater operations of \$18,137,502 results in total combined water and wastewater revenues of \$65,302,524.

- 21. Pending the establishment of permanent rates in this proceeding, Applicant requests interim water and wastewater rates which are set forth in Volume II of Applicant's MFRs. These interim rates are based on the test year ended December 31, 1995 and will produce additional sales revenues for consolidated water operations of \$7,428,460 and for consolidated wastewater operations of \$4,920,387. The combined increase in revenues from water and wastewater operations of \$12,348,847 results in total combined water and wastewater revenues on an interim basis of \$54,499,601.
- 22. Applicant requests that the Commission approve the proposed allowance for funds used during construction ("AFUDC") contained in Volume III, Books 1 of 6 and 2 of 6 of the MFRs; allowance for funds prudently invested ("AFPI") contained in Volume VII of the MFRs; and service availability charges contained in Volume VIII of the MFRs. Appendix F provides a list of the previous Commission orders that established AFPI and service availability charges. Applicant has provided the information required under Rule 25-30.434, F.A.C. and Rule 25-30.565, F.A.C. for AFPI and service availability charges in Volumes VII and VIII of the MFRs, respectively. The testimony of Forrest L. Ludsen and Charles Bliss explain the basis for the requested changes in charges and, together with the information provided in Volume VII and VIII, demonstrates the appropriateness of the proposed charges.
- 23. Applicant requests that the Commission approve the division of water service areas into two service classifications, Conventional Water Treatment and Reverse Osmosis Water

Treatment, and that the Commission approve uniform rates for each of these service classifications. Applicant further requests approval of uniform rates for the 44 wastewater service areas included in this Application.

- 24. Applicant requests that the Commission find that the Lakeside, Spring Gardens, Valencia Terrace and Buenaventura Lakes service areas recently acquired or to be acquired by Applicant are part of Applicant's water and wastewater system.
- 25. Applicant expects to complete construction shortly of central laboratory analytical facilities in Volusia County. The lab will provide water and wastewater testing services for Applicant's facilities statewide and displace certain testing services provided by outside vendors. Applicant expects qualitative benefits and cost efficiencies from the centralized laboratory facilities.
- 26. Except as may be indicated in this Application, Applicant has no knowledge of any material facts at issue.

### WHEREFORE, the Applicant requests:

- A. that the Commission take jurisdiction over this Application;
- B. that the Commission allow Applicant to place into effect on a permanent basis rates which will produce additional operating revenues for its combined water and wastewater operations in the amount of \$18,137,502;
- C. that the Commission find that a fair and reasonable rate of return on Applicant's combined water and wastewater rate bases is 10.32% based on a return on equity of 12.25% for the test year ended December 31, 1996;
  - D. that the Commission allow Applicant to place into effect interim rates which will

produce additional operating revenues for its combined water and wastewater operations in the amount of \$12,348,847;

- E. that the Commission approve the AFUDC, AFPI and service availability charges filed herewith;
- F. that the Commission approve the proposed uniform rates for Conventional Water Treatment, Reverse Osmosis Water Treatment and Wastewater Service;
- G. that the Commission find that the Lakeside, Spring Gardens, Valencia Terrace and Buenaventura Lakes service areas each constitute part of Applicant's water and wastewater system; and
- H. that the Commission grant any other relief it deems fair, just, equitable and appropriate.


