



Dear Mr. Durbin:

We are in receipt of your application for non profit association exemption from PSC regulation, dated March 16, 1995. The application is deficient in the following respects.

1. As required by Rule 25-30.060(3)(g), F.A.C., provide a copy of the corporation's bylaws, which clearly show that the requirements for membership, and that the members' voting rights are one vote per unit of ownership. Also, it is my understanding that the ownership of Knight Island Utilities, Inc., has been turned over to the residents. Please confirm this in writing including the effective date.


2. As required by Rule 25-30.060(3)(g), F.A.C., provide proof that Knight Island Utilities, Inc. owns the land upon which the facilities will be located or other proof of its right to continued use of the land, such as a 99-year lease. The deed that was submitted is in the name of Knight Island Utilities, Ltd, a Florida limited partnership. The deed needs to be in the name of the Knight Island Utilities, Inc.

Please file an original and two copies of the requested information no later than July 19, 1994 with the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, FL 32399.
