

Following up on Wednesday's Prehearing Conference in the above docket, this is to advise that Tampa Electric Company accepts Staff's position on Issue 15 of the Draft Prehearing Order, with the oil backout true-up amount for the October 1994 through March 1995 being a \$222,410 over-recovery.
