COMES NOW, BellSouth Telecommunications, Inc. d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell"), to address the protection of confidential information requested by Staff.

The Staff of the Florida Public Service Commission has issued additional Florida PSC Audit Requests in the above mentioned matter, specifically Audit Request Nos. 13 and 14 (copies of the requests are attached hereto as Exhibit "A"). In these requests, Staff has requested, among other things, that Southern Bell furnish information which Southern Bell deems to be confidential business information. Southern Bell respectfully requests that the Commission and the Staff treat the subject information as confidential and proprietary.

Therefore, pursuant to Southern Bell's request and § 364.183, Florida Statutes, as amended by the Florida legislature during its 1995 session, this material requested by the Staff is exempt from § 119.07(1) of the Florida Statutes, and § 24(a), Article I of the Florida Constitution. Because of the change in § 364.183, it is not necessary for Southern Bell to file a Notice of Intent to Request Confidential Classification in order to protect the
